§ 1 Contract

The BUYER ordered from Renault Germany AG __ car/s RENAULT CLIO RS IV Version „CUP“.

§ 2 Vehicle description

(1) Type: Renault Clio RS IV Version „CUP“, ready to race
Without options, model 2019, engine type Renault M5Mt, incl. FT3 Tank

(2) The BUYER is aware that the vehicle comply with the certain product of the German market. All vehicles are not provided for admission in traffic and therefore are not homologated and are not provided with a type customarily used for RENAULT CLIO chassis number by RENAULT. All vehicles are supplied without vehicle registration and COC-document.

It is up to the BUYER to order a car pass for use in motorsport at Renault or the DMSB.

§ 2a Deposit

By ordering a vehicle a pre-payment of 10.000,00€ on the purchase price has to take place to the bank account at Commerzbank AG. The purchase prize is 49.900,00€ ex VAT.

§ 3 Delivery

The vehicle only comes to delivery, when it is completely paid including all accessories.

Renault provides the vehicles in defined state for collection on the premises of Renault Germany AG 50321 BRÜHL.

With the delivery of the vehicles to the BUYER the risk of loss passes to the BUYER.

§ 4 Guarantee and liability for defects

(1) The vehicles are designed for use in racing and are therefore sold under exclusion of any statutory liability for defects.

(2) The vehicles are sold without any warranty promise. In particular, do not apply any new car warranty, paint and corrosion breakthrough and mobility warranty. The BUYER agrees to point out the absence of any warranty promise in writing to the third party when reselling the vehicle.

§ 5 Fees
